FROM THE PRES.....

I have just finished the flyer announcing the March visit of Mr. & Mrs. Lincoln (Max & Donna Daniels) to the Kansas City-Independence area.

During their two day stay in the area I will take them to Fort Leavenworth to visit the Lincoln Carriage at the museum, the Buffalo Soldier's Memorial, General Grant's Statue, and Tom Custer's gravesite, with it's Two Medals of Honor marking.

Tuesday evening there will be a **Dinner with the Lincoln's** gathering which will include a meal, social time and Civil War dance with a very nominal cost.

Wednesday evening will be the presentation of **The Lincoln's of Illinois** at our Round Table meeting. Both Mr. Lincoln and Mrs. Lincoln will speak.

Sponsors are still needed. The cost is only \$20.

Item...The Postal Service has taken off the market the Civil War Series. Those who did not get the mis-printed Civil War post card set are now out of luck. I am told there are still a few of the books which detail the lives and activities of those on the stamp set. These have been distributed to the Postal Service Philatelic Centers.

There are also a few of the first day of issue booklets which include a sheet of the stamps stamped First Day of Issue, Gettysburg, Pa. Cost is only \$9.95

Item...I received a mailing from the committee which is trying to save the Brandy Station Battlefield. The developer involved has agreed to sell back to the committe the part of the battlefield which was to become a shopping Center. A down payment has been made and a large payment is due soon. The committee to save Civil War Battlefields has tendered a large donation but a sizeable amount remains to be raised. Contact Mary Ann Hazzard if you are interested in helping out this very worthy cause.

Item...I read in the St. Louis Round Table news letter that several other Round Tables were a part of this new Missouri Round Table group. The published list of officers includes only those from St. Louis and Kansas City.

Our Board decided to take a wait and see approach to this new group since we were not invited to participate and have not received any communication from them.

Item... Word is getting around about a new Civil War movie to be filmed next spring. about the Battle of Shiloh. Some of the filming will be during the big re-enactment at Shiloh in April. What a time to visit that area. Watch some of the filming, visit the Shiloh Battlefield and nearby Corinth, Mississippi. Many area re-enactors will be involved in the re-enactment as well as the filming. Word is motels in the area are already booked solid.



Dear Fellow History Buffs,

The Civil War Round Table of Western Missouri is pleased to announce that Max and Donna Daniels, of Wheaton, Illinois, will be visiting the Kansas City area on Tuesday, March 11 and Wednesday, March 12, 1997.

Mr. and Mrs. Daniels are widely known for their first person impressions of Abe and Mary Todd Lincoln. So much so that it was Max who portrayed Lincoln in two episodes of the recent A & E series on the Lincoln-Douglas Debates.

Mr. and Mrs. Daniels are also recognized as among the most knowledgeable of historians of the Lincoln era.

His dress, voice and mannerisms are based on Mr. Lincoln's known appearance and characteristics, as are hers. He defends her on every subject, even shoes.

The Daniels' have never been to this area before. It has taken over two years to clear all the hurdles to make this trip possible.

Plans have been made to have them visit the Museum, Buffalo Soldiers Memorial and Gen. Grant; statue at Fort Leavenworth on Tuesday morning.

Imagine taking a photo of Max, in his Lincoln outfit, helping Donna, in her fancy attire, out of the Lincoln carriage at the Fort Leavenworth Museum.

The possibility of a reception and short program at the Museum or a luncheon of some kind to benefit a local historical group is also being considered.

There will be a dinner with the Lincoln's on Tuesday evening. Cost of the dinner, program and Civil War period dance will be \$15 per person or \$25 per couple with a 20% discount to those in period dress. Site of the dinner to be announced at a later time.

The final appearance of the two day trip to Kansas City will be a special presentation on *The Lincoln's of Illinois* at a meeting of the Civil War Round Table of Western Missouri on Wednesday evening at 7 pm at Truman High School.

The possibility of a school visit is open on Tuesday afternoon or Wednesday morning. If you know of a school that would like to host such a visit please contact us.

Other possibilities include a reception at an area historical home, like the Bingham-Waggoner Home, the Wornall Home, the Vaille Mansion or the Alexander Majors Home.

Mr. Daniel's fee for school programs is \$75, \$100 if both of them appear. His fee for receptions and the like is \$50, \$75 if both appear.

The CWRTWMO is picking up all the travel, meal and motel expenses leaving only the appearance fee to be picked up by the school or historical group.

Forty Years Later...

from Gettysburg Magazine, Vol. 15, pg 4

On a return visit to Spangler's Spring with his grandson in 1903, aging veteran John Care related the following story.

Then a lieutenant in Co. I, 46th Pennsylvania Volunteer Infantry, Ruger's Brigade, William's Division, Twelfth Corps, John Care was there on the night of July 2-3, 1863.

As told by the grandson...

"...there in the darkness, forty years before, he had come to the spring to fill canteens for his men. He said that he had rested there, and in the process he and a Rebel had traded sugar and coffee for tobacco. They traded and spoke quietely for a while; then Care had gone back to his line. Then he said that a little while later they had gone back to killing one another."

The 21 Gun Salute

Early military manuals had very little on military burial rites.

The British had a custom of firing a broadside of seven cannons when an officer was buried at sea.

In the U.S. in the early 1800's, the way to give Honors at a U.S. officer's burial was to use 21 guns in 4 ranks.

First Rank 1 gun 7 guns Second Rank Third Rank 7 guns

6 guns Fourth Rank

The ranks fired 3 seconds apart and held their muskets at Present Arms after firing.

By the end of The War of 1812, this system was all but forgotten.

Even during the early days of the Civil War no provisions were given for the burial of enlisted men.

When the laws governing the awarding of Medals of Honor were changed to include the men in the ranks as well as the officers, in July of 1863, so also were the guidelines for soldier's burials.

The 1893 G.A.R. Manual had several kinds of burial rites listed, including rank, religion and race.

Officers were to receive a 7 gun salute, enlisted men a 5 gun salute.

In some areas the old 1-7-7-6 system was revived for special occasions using 3 ranks of 7 guns.

The system was as follows...

1st Rank, 1st Gun Only Fire 2nd Rank, All 7 Guns Fire 3rd Rank, All 7 Guns 1st Rank, last 6 Guns 3 seconds between volleys.

By the end of WWI, all military personnel were receiving the same salute, 1 rank of 7 guns, 3 shots.

According to the Manual of Protocol, only the President, Commander-in-Chief, or a foreign head of state visiting the President, receives a full 21 gun salute. Yet, every once in a while there is a story about an old veteran, usually a Civil War soldier, receiving a full 21 gun salute when in fact this is improper and not in keeping with protocol.
