Multnomah Site Search To Be November 18th

The trail from Liberty to Fort front door for nearly 40 years.

The man who built it established trading posts at Fort Leavenworth. Fort Kearney, Fort Laramie, and Riboudioux Pass.

The complex once included over 6,000 acres, 200 slaves, its own mill. salt lick, water system and cemetery.

Today, hundreds of cars drive by daily and have no idea of what once was there or its historical value.

The ruins of the old cabin, built in 1859, are still visible, nearby.

A few of the thornless black locust trees, brought from the east in 1859 by Mr. William Claybrook of Centerville, are still evident.

One can stand on the bank and still see the swails of the old trail as they come from the south, cross the rocky ledge bottomed creek and head off toward the fort.

Our plan is to grid off the site of the old mansion and search each grid for any artifact which might tell us more of the buildings past.

Information which may save this site from a developers bulldozers.

In the afternoon session, 1 pm to 4 pm, we will attempt to search out the creek bed and crossing for artifacts, possibly even trace the trail back across the hill.

Of course we will visit the ruins of the old cabin.

Each searcher must check in when they arrive. The registration tent will be at the farmer's lane.

No outsiders will be allowed onto the private property.

Others from a metal detecting club and a dowsers society may be a part of the search team.

Gloves, garden tools, notepads, and pencils will be needed.

November's Program The Confederate Home of Missouri

In 1984, I started a project to correct all the errors on the burial listing of the Confederate Cemetery which was part of the Confederate Home at Higginsville.

I had three lists to work from and several rosters of inmates.

Of the over 800 names listed on the most commonly published list I found errors on 154.

I ended up going to the original applications and having to check each one for initials, units, etc.

Then to the weekly column about the Home in the Higginsville paper.

I soon discovered there was a system to the burials and by crossing the burial dates and locations with the obits I was able to identify some of those in unmarked graves.

I then broke down the rosters and made lists of the states the men came from and, in some cases, the units they served in.

All of this data was turned over to the administrator of the site.

I have copies of the bi-annual rosters, medical reports and a row by row listing of the cemetery as well as an alphabetized listing.

I have never done a program utilizing the data I have collected on the Home. This will be a first.

My intention is to use slides, overheads and handouts to share as much of the data as possible.

Although the facility did not exist, officially, until 1893, there are burials in the cemetery dating from 1891. The State took over in 1895.

So, Where did the idea come from to have the Confederate Home of Missouri in Higginsville?

And what happened to all the buildings and the farm?

Who were the last "inmates" at the place and when?

Did you know that one child was born at the Home?

Many documents will be shown.

Misprinted Postcards

It would take more space than I have available here to tell of the hassle it was to get the misprinted Civil War postcards, but it is done.

Our Round Table is set up as a vendor for the U. S. Postal Service Philatelic Service Center.

We have an account number, service representative, the whole bit.

I ordered all items related to the Civil War and Legends series.

The panel of six sets of ready to cut Civil War Stamps is striking.

The postcards were a surprise. I expected the stamp to be on the back and all that but I did not expect the front to be a full size blowup of the actual stamp itself.

The full set of 20 postcards are in a plastic wrap. The question now is will opening the wrap to look at the cards destroy the value. Item #8833.

Set #88833 is postmarked Gettysburg, First Day Issue.

The commemorative book is outstanding. Beautifully done with great pictures and informational data. I highly recommend you check out this item. Item #8830

The biggest surprise was the First Day Program. This little booklet includes a copy of Ballew's famous letter to his wife and a full set of Civil War stamps postmarked Gettysburg, First Day Issue.

This is the only way you can get the canceled stamps and it has not been promoted. Item #8832.

I also picked up a copy of the Legends of the West commemorative book. The quality and content of this book also far exceeded my expectations. Item #08826.

The First Day Issue Program includes a set of Legends of the West stamps which are postmarked in Laramie, Wyo, Tucson, Ariz. and Lawton, Okla. and stamped First Day Issue. Item #9925 (Only S6).

Items will be on display at the November 8th meeting.
